Mayor Spicer announced condolences to the City of Streator and the family of Mayor Ray Schmidt on his recent passing.

Mrs. Sue Rezin introduced herself to the Village Council and announced her candidacy for representative of the 75<sup>th</sup> District.

Old Business:

Public Health & Safety Sears:

Commissioner Sears stated after accepting opinions and information from Seneca residents, that the current burn ordinance will remain enforced as it is. This was approved unanimously by the Council members present.

Accounts & Finance Timmons:

Commissioner Timmons read an announcement regarding the Seneca Historical Guild including next meeting information as well as Guild memorabilia requests.

Streets Lamb:

Due to Comm. Lamb's absence, Guy Christensen of Chamlin & Associates gave a creek cleaning update; he stated that cross section, restoration and clean up will resume when weather permits.

Public Affairs Spicer:

Mayor Spicer announced the previously discussed amendment to ordinance #09-18 relating to water/sewer rates. On March 2, 2010, a motion was passed allowing Senior Citizens 65+ who apply for a discount and are in Village Limits, be given a \$7.50 break on their water billing.

A motion was made by Comm. Sears and seconded by Comm. Timmons that the Council adopts ordinance #10-04, an ordinance amending the ordinance regulating water user charges in the Village of Seneca.

New Business:

Public Health & Safety Sears:

Commissioner Sears stated that the Police Department received a grant for cigarette compliance checks. An announcement was made that after the first check was completed that each Seneca business tested passed the anonymous testing.

Comm. Sears also announced that the police department is applying for another grant relating to traffic enforcement. A radar unit used by police employees became unusable due to malfunction.

A motion was made by Comm. Sears and seconded by Comm. Timmons that the Council approves an expenditure of \$1510.00 for the purchase of a radar unit.

Commissioner Sears stated that part-time police officer Sean Beeler resigned due to not being able to work assigned hours.

Public Affairs Spicer:

Mayor Spicer announced the Village was asked to send a letter of support and pledge toward the proposed LaSalle County Broadband Initiative program. The program is designed to match grant funding and bring unrestricted, high speed broadband access across LaSalle County. It was the consensus of the Council to send the letter of support but at this time the Village is not committing to pledge funds.

Mayor Spicer announced that the following appointments are up for term renewal at this time: Michelle Balsitis, Ray Meglan, Doreen Hall and Jackie Brewster.

A motion was made by Comm. Sears and seconded by Comm. Timmons that the Council approves the re-appointment of Michelle Balsitis to the 911 Board with term ending 5-1-13.
